## Inscriptions to the 2007 MAXXIS FIM Enduro World Championship

Dear Sir or Madam,

Please find here below Art. 062.12 of the 2007 Enduro Regulations concerning the procedure of inscriptions to the 2007 MAXXIS FIM Enduro World Championship:

### *"062.12 INSCRIPTIONS AND PARTICIPATION*

*The total number of participants at each event is 150 (Enduro 1, Enduro 2, Enduro 3 and Enduro Juniors mixed).*

*The following are admitted to participate in the Enduro World Championship and in the Junior Enduro World Cup, in order of priority:*

- 1. all the riders who scored points in the World Championship and in the Junior Enduro World Cup of the previous year*
- 2. the 5 best riders of each class from the Continental Championships of the previous year who scored no points in the World Championship and in the Junior Enduro World Cup of the previous year*
- 3. the riders who scored points in the World Championship and in the Junior Enduro World Cup of the current year*
- 4. riders can be added to the list, up to a maximum of 150.*

*The CER is authorised to complete the list with wild card riders.*

*No entries shall be accepted after the closing date of the inscriptions.*

*The FMNR must send the entry list to the FIM Executive Secretariat 30 days before the event.*

*The maximum entry fee must be US\$ 200.- and must be paid at the latest 15 days before the start of each event. This amount will be settled through the FMN of the rider directly to the organiser. The organiser can accept the inscription payment during the preliminary inspections plus 50% if the conditions (see Article 062.3) are respected.*

*Any cancellation certified by the FMN will be totally reimbursed if the cancellation is confirmed within three days of the preliminary inspections."*
